Eligibility and exemptions

For 12th passed students ('Minimum 65% marks in Accounts or Math' and 'Minimum 65% marks in English' and 'Minimum 50% marks in other subjects'). If the students are having less mark for minimum entry requirement for ACCA, then the students can enter into ACCA by passing 3 papers of "Diploma in Accounting and Business (FFA, FFB, and FFM) of Foundation of Accounting of ACCA". After successful completion a student will be also exempted from F1, F2, and F3; can start from F4 at Skill level.

Skill level is next level at foundation after Knowledge level.

Eligibility

Student who enrolled for knowledge level of ACCA can start skill level papers simultaneously; Mean student can write paper F5 to F9 even if any of Paper F1 to F3 is pending. But who so ever come through FIA/CAT route first have complete FIA/CAT papers to exempt their knowledge level papers.

- **Exam** –Exams at this level are available as both, CBEs (Computer Based Examination) or paper pen mode. Find the list of CBE centre on http://www.accaglobal.com/in/en/student/exam-entry-and-administration/computer-based-exams/on-demand-cbes/cbe-centre-list.html
 - Exams are held 4 times a year, in month of March, June, September and December
 - Scheduled usually from first Monday to Friday of these month as; Monday (F8), Tuesday (F7), Wednesday (F5), Thursday (F6) and Friday (F4 and F9)
 - Since exam of F4 and F9 are held on same day, so students are advised not to go for F4 and F9 in same term to avoid clash of date.
 - Each exam is of 100 marks, with 60 % objective (Except Paper F8) weight-age.
 - Student can appear in any number of paper maximum upto 4 in single term in any order.
- ❖ Pass Criteria and Result Student who scored 50% marks in individual paper is declared pass in that paper. Result is declared on 3rd Monday morning of succeeding month to month of exam for example result for June 2020 term will be released on 16th July 2020.

ACCA - Professional Level

This is final level of ACCA curriculum.

Eligibility

One who passed or exempt the Foundation level (Both Knowledge and Skill level) can start strategic professional level. Note – It is allowed to student to write foundation level exam which is pending with professional level exam. Mean Student can write F8 or F9 (any of pending paper at foundation level) with any of Professional level exam. **No Exemption is allowed at professional level**

Registrations remain open throughout year.

- **Exam** –Exams at this level are available as paper pen mode.
 - Exams are held 4 times a year, in month of March, June, September and December
 - Scheduled usually from first Monday to Friday of these month as; Monday (P7), Tuesday (P6 and Strategic Business Leader), Wednesday (P5), Thursday (Strategic business reporting) and Friday (P4)
 - Since exam of P6 and Strategic Business Leader are held on same day, so students are advised not to go for P6 and Strategic Business Leader in same term to avoid clash of date.
 - Each exam is of 100 marks, with case study type questions.
 - Student can appear in any number of paper maximum upto 4 in single term in any order.
- ❖ Pass Criteria and Result Student who scored 50% marks in individual paper is declared pass in that paper. Result is declared on 3rd Monday morning of succeeding month to month of exam for example result for June 2020 term will be released on 16th July 2020.
- **Membership** Professional level pass students have to complete following to apply for membership.
 - Ethics and Professional Skills module of 20 hrs
 - 36 Months practical experience requirement (PER)
